

# **President Trump Holds News Conference Addressing Claims Surrounding Nicolás Maduro**

President Donald Trump held a high-profile news conference following widespread attention around claims involving Venezuelan leader Nicolás Maduro. The administration's messaging strategy appeared designed to balance transparency with restraint, ensuring that public statements did not escalate tensions unnecessarily.
