

# **Suspect Arrested After Dramatic Ambulance Chase in Southern California**

A dramatic police pursuit involving a stolen ambulance ended with a suspect in custody after a multi-agency chase through parts of Southern California. The unusual incident, which unfolded across busy city streets and highways, raised serious concerns about public safety and highlighted the risks associated with emergency vehicle misuse.

Law enforcement officials confirmed that the suspect was arrested without serious injuries after the ambulance was stopped following an extended pursuit. Authorities are now investigating how the vehicle was taken and whether additional charges will be filed.

## **Law Enforcement Response and Strategy**
