

Driver Sought After Hitting Pedestrian Crossing Street in Frayser, Police Report

Authorities are searching for a driver following a hit-and-run incident in the Frayser neighborhood, where a man was struck while crossing the street. Police say the driver failed to stop at the scene, prompting an active investigation and renewed concerns about pedestrian safety in the area.
